



**STATE OF UTAH  
OFFICE OF THE LIEUTENANT GOVERNOR**

In accordance with Utah Code § 20A-9-403, the Office of the Lieutenant Governor certifies the numbers below as the signature requirements for Qualified Political Party candidates for the 2020 Election Cycle. As of September 30, 2019, each political party in Utah is classified as a Qualified Political Party.

Candidates—with the exception of State Board of Education candidates—must collect signatures from voters who are eligible to vote in the party's primary election and reside within the office's district or area. State Board of Education candidates must collect signatures from voters who are affiliated with the political party and reside within the office's district or area.\* The table below lists the voters who can participate in each party's regular primary election:

Party	Voters permitted to vote in party's regular primary election
Constitution Party	Voters affiliated with the Constitution Party
Democratic Party	Voters affiliated with the Democratic Party and unaffiliated voters
Green Party	Voters affiliated with the Green Party
Independent American Party	Voters affiliated with the Independent American Party and unaffiliated voters
Libertarian Party	Voters affiliated with the Libertarian Party
Republican Party	Voters affiliated with the Republican Party
United Utah Party	All voters, regardless of affiliation

Signature requirements for county offices are equal to 3% of all voters eligible to vote in the party's primary election and resides within the office's district or area.\*\* Not all county offices are up for election in 2020, but all offices are listed to account for potential vacancies. Check with your county clerk to determine if an office is up for election.

\*Candidates for State Board of Education must collect the lesser of: (1) 2,000 signatures of registered voters who are permitted to vote in the party's regular primary election and reside within the district; or (2) 3% of the registered voters who are affiliated with the political party and reside within the district.

\*\*Grand County currently holds non-partisan county elections. The signature requirements provided below are provided in the event that it holds partisan county elections.
