Notice is hereby given that the Cities have requested Uintah County Commission to call for an Opinion Question to be placed on the General Election Ballot, for the purpose of authorization of the imposition of a local sales and use tax of one quarter of one percent (.25%) to fund motorized and non-motorized transportation projects, corridor preservation, congestion mitigation, or to expand capacity for regionally significant transportation facilities in Uintah County. This sales tax election shall be a mailed ballot, at which there shall be submitted to the qualified electors of Uintah County the ballot proposition appearing in the election Notice attached hereto as Exhibit A. Polling places, time and election officials will be the same as already established by the Uintah County clerk for the General Election. All qualified voters shall be entitled to vote either for or against the proposal. The General Election will be held on the 7 day of November, 2017.

A public hearing will be held October 19, 2017 @ 6pm in the Uintah County Commission Chambers.

The tax will only apply to non-food items.

This will benefit Uintah County, Vernal City, Naples City, Ballard City, and The BTA.

The revenue will provide stability to transportation budgets within the County and Cities.

Duchesne County Passed Prop 1 in 2015 (same as Prop 5) and they are able to provide solutions to long standing issues such as: sidewalks, curb & gutter, and making it safer to walk within the County.

Funds will support the Wellness Wagon.

Funds will help the improvement of roads, sidewalks, pot holes, and trail development.

The revenue will help support BTA, **not** UTA (Utah Transit Authority), which will help families with limited transportation and/or disabilities get to Dr. Appointments, shopping, and other events/activities in the community.

BTA will assist citizens with transportation to schooling such as: Terra Academy, USU and UBTEch

As more people use BTA, it will help cut down on congestion and pollution we suffer from in this area.

Helps families with limited transportation visit family members throughout the Basin.

Prop 5 revenues can be used as match funds when applying for grants.

Sales tax is more favorable to the residents than property tax because visitors to our area will also contribute when they purchase non-food items.
