Uintah County is requesting applications from qualified Defense Services Providers for eight (8) separate contracts to provide indigent legal services in the 8<sup>th</sup> Judicial District, Juvenile, and associated appeals as outlined below:

- 2. 1/4 District Court
- 3. 1/4 District Court
- 4. 1/4 District Court
- 5. 1/3 Juvenile Delinquency and Child Welfare
- 6. 1/3 Juvenile Delinquency and Child Welfare
- 7. 1/3 Juvenile Delinquency and Child Welfare
- 8. Appeals District, Juvenile Delinquency, and Child Welfare

The budget for each type of contract is as follows: \$7,500/month for each District Court contract, \$7,000/month for each Juvenile Court contract, and up to \$10,000 for a 12-month appeals contract. Uintah County has hired a Managing Public Defender and Legal Assistant to manage and oversee all public defense work in Uintah, Daggett, and Duchesne Counties. Management and Oversight includes, but is not limited to: approval of defense resource requests, courtroom observation, mentorship, case assignments, conflict management, performance reviews, trainings, etc.

Public Defender Services are professional services and not subject to the procurement code. Applications (*attached*) are due to the Uintah County Clerk-Auditor's Office at 147 East Main, Vernal, Utah 84078 no later than **5:00 p.m. November 9<sup>th</sup>**, **2018**.

By November 13<sup>th</sup>, 2018, the Uintah County Clerk-Auditor will distribute the applications to a Selection Committee which will conduct in-person interviews. The Selection Committee consists of:

- Deputy County Attorney Civil
- Managing Public Defender
- Indigent Defense Commission representative(s)
- One Uintah County Commissioner
- Retired Judge

Each finalist selected by the Committee will be presented by the Managing Public Defender to the Uintah County Commission during its public meeting on **November 26**<sup>th</sup>, **2018 at 11:00 a.m.** Further discussions or interviews may be conducted and revisions of the proposals are allowed. It is anticipated that final contract awards will be made during the same meeting, but circumstances may necessitate awarding on a future date. Selected Providers must be available to begin work by January 1, 2019. However, because of current vacancies in contracts, Uintah County is in need of some applicants to begin as soon as possible.

Selected providers will be required to comply with the standards of representation related to the Indigent Defense Commission Grant and track and report both public defense and private caseloads, including time tracking on public defense cases. Uintah County will provide a case management system at no cost to providers.

Applicants NOT selected for a contract should indicate on the Application whether they wish to remain on a conflict roster for compensation at a rate of \$75 per hour.
